

PUBLIC NOTICES

1. TRANSFER OF THE GENERAL INSURANCE BUSINESS OF ALLIANZ INSURANCE COMPANY OF KENYA LIMITED

The Authority would like to inform the public about the transfer of insurance business as provided under Section 118 of the Insurance Act as follows:

- Transfer of general insurance business (excluding medical insurance) of Allianz Insurance Company of Kenya Limited to Jubilee Allianz General Insurance Limited
- Transfer of medical insurance of Allianz Insurance Company of Kenya Limited to Jubilee Health Insurance Limited

In view of the above transfers, the registration of Allianz Insurance Company Kenya Limited has been canceled as provided for under Section 187 of the Insurance Act.

2. ATLAS LIFE INSURANCE COMPANY LIMITED

The Authority's attention has been drawn to the activities of a company operating under the name "ATLAS LIFE INSURANCE COMPANY LIMITED" and hereby clarifies as follows:

- Atlas Life Insurance Company Limited is not authorized to transact insurance business in Kenya.
- It is illegal to buy insurance products from an insurer not registered under the Insurance Act

In the meantime, any person soliciting insurance business in the name of the said insurer should be reported to the Authority for appropriate action.

3. NOTICE OF OPERATION AS A CLOSED FUND BUSINESS- OLD MUTUAL LIFE ASSURANCE COMPANY LIMITED

Following the consolidation of long-term insurance business of the Old Mutual Group in Kenya, the Authority would like to make the following clarifications:

- Old Mutual Life Assurance Company Limited* is no longer transacting new insurance business. It however continues to operate as a closed fund under Section 21(A) of the Insurance Act. The Fund will continue servicing existing policyholders without taking new business.
- UAP Life Assurance Kenya Limited changed its name to *Old Mutual Life Assurance Kenya Limited* and continues to transact life insurance business and taking in new policies in line with the provisions of the Insurance Act.

4. REGISTRATION OF BANCASSURANCE INTERMEDIARIES
