IRA/130/2021-2022 - EXPRESSION OF INTEREST FOR PROVISION OF CONSULTANCY SERVICES FOR THE ASSESSMENT OF THE IRA ENTERPRISE RISK MANAGEMENT FRAMEWORK

1. Background

The Insurance Regulatory Authority (IRA or the Authority) is a State Corporation established under the Insurance Act, Cap 487 of the Laws of Kenya with the mandate to regulate, supervise and promote development of the insurance industry in Kenya. IRA has implemented various risk management practices in a bid to improve efficiency and effectiveness in execution of its mandate.

To ensure that risk management has been implemented in compliance with laws and best practice, the Authority wishes to engage a reputable firm to undertake an Audit.

2. Objective

The objective is to carry out a comprehensive review and examination of the risk management policy framework and processes applied in helping the Authority achieve its objectives. The focus shall be on effectiveness as well as maturity of risk management practices.

The specific objectives of the review shall be to: -

- i. Establish the desired level of maturity;
- ii. Review current risk management policies and practices;
- iii. Determine the gaps against the desired maturity level; and
- iv. Develop strategies for addressing the identified gaps.

The auditor shall report on the conclusions reached from his review of risk management and recommend suitable measures for correcting any deficiencies which are identified during the review process.

3. Scope of services

The areas of review include but are not limited to:

- i. Adequacy of the risk management policy framework.
- ii. Effectiveness of risk management processes applied.

- iii. Establish whether risks have been identified exhaustively and mitigated appropriately.

The tasks to be performed include but are not limited to:

- i. Assess effectiveness of the existing risk management policy framework and advice on gaps identified
- ii. Assess the level of implementation of risk management practices across the organization
- iii. Assess risk management awareness across the organization
- iv. Conduct interviews with staff and risk owners.
- v. Review available risk registers.

Outputs expected from the audit

The Auditor shall submit his audit report, which shall include but not limited to the following:

- i. Statement of objectives of the audit
- ii. Scope, nature, timing and extent of audit work performed
- iii. Detailed findings with appropriate recommendations and an implementation plan agreed on with Management to correct the deficiencies.

4. Eligibility criteria

The tender is targeted to the firms owned by Youth. However, it is also open to all other eligible bidders and margin of price preference will be awarded to the targeted group. The Expression of Interest must be accompanied by the consultants' qualifications, professional capabilities and documentary evidence of having successfully completed assignment/ project of similar nature. Interested firms should provide specific information which will be the basis for shortlisting and further invite to respond to comprehensive terms of reference as indicated below: -
