1	Kindly provide technical specifications for Video Conference codec	
2	A video Conference Codec does not work with integrated camera on the 86" display but requires its own/separate detachable camera- can we quote for such separate camera	The provided Screen should have a in-built Video Conferencing Codec that is capable of handling of 4K30 (minimum resolution) as specified under Camera requirements on page 89 of the tender document.
3	Mounting of the 86" Displayadvise wall/ceiling mounted or on trolley	Floor standing (with roller) to be provided as specified under General requirements on page 89 of the tender document.
4	Provide technical specifications of OPS Module—is it i5 or i7?	The performance should be no less than i7 – 10700 16G DDR4 RAM, and 512G SSD as specified under OPS Module requirements on page .90 of the tender document.

S/No.	Bidders Question	IRA's Response
5	What is the size of the room?	Approximately 11 metres long and about 5 metres width.
6	How many peoples are in conference room?	Approximately 18 to 20 pax
7	Wireless table microphone or wired table microphone?	The screen should have at least 6 in-built Microphone arrays as specified under Microphone Requirements on page 90 of the tender document.
8	Standing speaker or ceiling speaker?	The screen should come with a minimum of two in-built speakers with frequency response range of 100Hz -20 KHz
		as specified under Speaker Requirements on page 90 of the tender document.
9	How many tracking cameras? (Presenter and audience)	The screen should come with a in-built camera of 4K30 (minimum resolution). For tracking the speaker who is talking, the Camera should automatically switch to the close-up picture of the person who is talking without manual intervention as clearly specified under Camera Requirements on page 89 of the tender document.
